CITY OF LAVON, TEXAS**

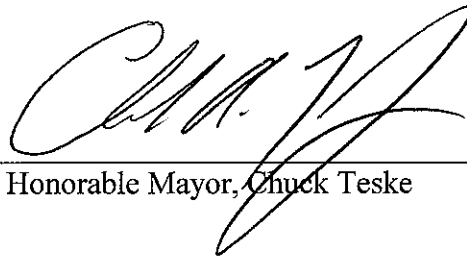

COLLIN COUNTY, TEXAS;**

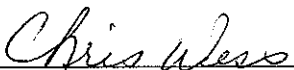
